1. RULES AND REGULATIONS

This championships, organised by Multi-ball games Administrative Center of the General Administration of Sport of China and Chinese Bowling Association(CBA), and this championship is sanctioned by the Asian Bowling Federation (ABF), International Bowling Federation (IBF), will be conducted in accordance with World Bowling Playing Rules as of September 2019. Current Frame Scoring System will be used.

5. CLASSIFICATION

U22 International Group : open to youth and girls born on January 1, 2001 or after

6. EVENTS

U22 International Group (Mixed)

There will be no respective division for Boys and Girls. Girl bowlers are given a handicap of 6 pins per

game in the championships, and capped at 220 points.

i. Qualifying Round: 8 games in one blocks. The top 44 bowlers shall qualify for Final Round 1.

ii. Final Round 1: 4 games in a block with the scores from foregoing 8G carried forward. The top 16

bowlers shall qualify for the Elimination Rounds with the total of 12 games.

iii. Elimination Round (Matches Chart): The top 16 qualifiers shall bowl a best of 3 games elimination

round.

iv. Quarter Final Semi Final & Final (Matches Chart): Best of 3 games

7. TIE SCORE

In case of a tie for 44th position for Final Round 1 & 16th position for elimination round, who do not

have handicap will be listed first. If there is a tie for handicap, ONE BALL ROLL OFF;

Elimination Round tie breaker ONE BALL ROLL OFF;

Quarter Final / Semi Final / Final ONE BALL ROLL OFF;

8. AWARDS

Medals will be awarded to the top three positions and certificates will be awarded to the top eight

positions.

9. FEES

Registration Fee for U22 International Group RMB\$500.00 per person.

11. REGISTRATION OF BOWLING BALLS

All bowling balls used in the Championships must be registered prior to competition. Participants in U22 International Group must bring their own bowling balls and shoes that conform to the competition rules. The competition ball will be allowed to be used only after passing ball inspection;

12. BOWLERS' ATTIRE

- **a.** All personnel of each team shall dress in accordance with the regulations of the International Bowling Federation during the competition.
- i. T-shirts with short-sleeved collars (lapels and collars are fine);
- ii. Men are uniformly dressed in monochrome western pants or casual western pants; women may wear pants and short skirts;
- iii. Men may not wear sweatpants, jeans, leggings, shorts, nine-point pants, seven-point pants, and women may not wear jeans, sweatpants, or bodybuilding pants.
- **b.** Can appear on the competition clothing
- i. Name of the athlete;
- ii. The name of the province or city region;
- iii. The logo of the provincial or municipal regional association represented by the athlete;
- iv. The size of advertisements presented on the apparel must not exceed half the size of the font on the back of the athlete's apparel, and the content must comply with relevant national laws and regulations. In order to coordinate the interests of all parties, the competition stipulates that the clothing of each participating team and the main sponsor of the conference Clothing advertisements must not be unique. Each team clothing advertising team name before such as the crown enterprise Industry name, the total number of words should not exceed 8 words.
