



6th MEGALANES SENIOR MASTERS 2026

(July 28 – 31, 2026)

Sanctioned by Malaysian Tenpin Bowling Congress, Asian Bowling Federation & International Bowling Federation

1. OBJECTIVE

The objective of this Tournament is to foster and promote goodwill, friendship and sportsmanship amongst the senior bowling fraternity.

2. ORGANISATION & SANCTION

The 6th Megalanes Senior Masters is organized by Sunway Mega Lanes and sanctioned by Malaysian Tenpin Bowling Congress, Asian Bowling Federation and International Bowling Federation. World Bowling Playing Rules and Regulations as of September 2019 shall apply on matters not covered herein.

3. ELIGIBILITY

This tournament is open to bowlers who are 50 years old and above (Born in 1976 and before). All current MTBC members of good standing and only foreign bowlers from ABF Federation and International Bowling Federation are eligible to participate in this Tournament. Foreign bowlers must obtain clearance from their respective National Tenpin Bowling Association.

4. FEES

Registration Fee – RM1000.00 per bowler (inclusive of 3 blocks and victory banquet)

Desperado Fee – RM150.00 per bowler

Masters Final Fee - RM200.00 per bowler

5. TOURNAMENT FORMAT

Classic format in which each player will bowl 3 blocks of 5 games each with handicap over 3 days during each assigned squad.

The top 64 Men's plus 8 Desperado and Top 40 ladies plus 8 Desperado will proceed to Masters Final. Masters Final will be 8 games roll off for each category.

7. REGISTRATION OF BOWLING BALLS

All urethane and mixed urethane coverstocks balls, will be prohibited in this Championship.

It is the bowlers' responsibility to ensure that all bowling balls used during the Tournament are verified for correctness of weight and other specifications. If in doubt, the ball may be verified by the Tournament Technical Committee. The Tournament Technical Committee reserves the right to recall any ball(s) for inspection at any time.

8. TIE BREAKING PROCEDURES

(a) When a tie occurs after the 3rd block, the player with the highest last game in the 3rd block with handicap shall determine the positions.

(b) When a tie is registered which will affect the awards of prizes, the prizes will be shared equally among the winners.

9. AWARDS

Prizes in the form of Cash Vouchers will be awarded to the winners.

10. VERIFICATIONS OF SCORES

It is the bowlers' responsibility to ensure that the correct score for each game is recorded in the official score sheet by signing on the official score sheet.

11. BOWLERS ATTIRE

Bowlers are requested to be dressed for their events with a sense of decorum.

12. PROTEST

12.1 Scores : Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the event. No protest made after the prize presentation will be entertained.

12.2 Eligibility : Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the first infringement.

13. SPECIAL NOTES

The Tournament Directors, or, in his absence, his appointed official on duty, reserves the right to accept or reject any entry as deem fit. Any matters arising which are not covered in these Rules and Regulations will be decided by the Tournament Directors. The decision of the Tournament Directors shall be final. Such appeal should be made in writing and within 12 hours of the decision by any of the above.
